Privacy Policy Statement

These are the privacy policy statement which apply to the website accessible at www.1d.com (Website). The Website is operated by GOLD FORTRESS CAPITAL LIMITED ("GOLD FORTRESS" , "we" , "us" or "our"), a company incorporated in New Zealand with its principal place of business at 24a Seaside Avenue, Waterview, Auckland, 1026 , New Zealand. By your use of any website operated by GOLD FORTRESS or any of our affiliates or opening an Account with GOLD FORTRESS, you give your consent to the collection and use of personal information by GOLD FORTRESS as explained in this statement.

What is personal information?

Personal information includes any information or opinion, about an identified individual or an individual who can be reasonably identified from their information. The information or opinion will still be personal information whether it is true or not and regardless of whether we have kept a record of it. The information that we seek to collect about you will depend on the products or services that we provide. If you do not allow us to collect all of the information we request, we may not be able to deliver all of those services effectively.

For what purposes do we collect, hold, use and disclose personal information?

The main reason we collect, use, hold and disclose personal information is to provide you with products and services. This includes:

- * checking whether you are eligible for the product or service;
- * providing the product or service; and
- * helping manage the product or service.

We may also use your information to comply with legislative or regulatory requirements in any jurisdiction, prevent fraud, crime or other activity that may cause harm in relation to our products or services and to help us run our business.

We may also use your information to tell you about products or services we think may interest you.

How do we collect personal information?

We collect most personal information directly from you. For example, we will collect your personal information when you apply for or use a product or service or talk to us in person, on the phone or via other communication methods (e.g. email or facsimile). We may also collect your personal information through monitoring or recording conversations to protect you in your dealings with us and to provide a record in the event of a dispute about the transaction. We also collect information from you electronically. For instance, when you visit our website or whenever you apply for or access GOLD FORTRESS products and services electronically. Sometimes we collect personal information about you from other people or organizations. This may happen without your direct involvement. For instance, we may collect personal information about you from:

- * other GOLD FORTRESS Group companies;
- * publicly available sources of information, such as public registers;
- * your representatives (including your legal adviser, mortgage broker, financial adviser, executor, administrator, guardian, trustee, or attorney);
- * other organizations, who jointly with us, provide products or services to you; and
- * commercial information service providers, such as companies that provide fraud prevention reports.

Who do we disclose your personal information to?

We will not sell, license, lease or otherwise disclose your personal information to any third party for any reason, except as described below.

- * external service providers and professional advisers (which may be located overseas) that provide services to us;

* any organization at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant;

* credit reporting agency, any credit provider named in the report and any credit provider whose details have been provided to us by you;

* regulatory and government bodies from time to time in New Zealand and other countries; and its associates.

GOLD FORTRESS takes all reasonable steps to protect your personal information from misuse, loss, unauthorized access, modification or disclosure.

What do we collect on GOLD FORTRESS Websites?

The Website (accesses in www.1d.com) is operated by GOLD FORTRESS Brokers. We collect statistical information about visitors to our websites such as the number of visitors, pages viewed, types of transactions conducted, time online and documents downloaded. This information is used to evaluate and improve the performance of our websites. Other than statistical information, we do not collect any information about you through our website unless you provide the information to us.

We use cookies and other technologies (collectively, "cookies") to provide us with data we can use to improve your experience and to know you better. Cookies are small text files sent from various web servers that may be stored on your computer. Cookies enable us to capture how you arrived at our website, how often you visit when you return, which pages on our website you visit, and to recognize when you are logged on when we receive a request from your web browser. We may link the information we store in cookies in order to identify information you submit while on our website. Cookies are readable only by us and do not contain any personal, financial or Account information. We cannot and will not gather information about other websites you have visited in the past.

All web browsers have settings that allow you to block cookies. By visiting our website with your web browser set to allow cookies, you consent to our use of cookies as described above. If you choose to block cookies you may use our services, however, some functions and features may be disabled or not may not work as they were initially designed to.

Resolving your privacy concerns and complaints –your rights

GOLD FORTRESS will open an account for you after you submit the personal information form requested by GOLD FORTRESS.

If you are concerned about how your personal information is being handled or if you have a complaint about a breach by your privacy, please contact us.

We will acknowledge your complaint as soon as we can after receipt of your complaint. We will let you know if we need any further information from you to resolve your complaint. We aim to resolve complaints as quickly as possible, but some complaints take longer to resolve. If your complaint is taking longer, we will let you know what is happening and a date by which you can reasonably expect a response.

demo platform for the limited purpose of trialing financial betting in accordance with these terms. No other rights are granted in respect of the platform.

The following behavior is prohibited (unless these terms or GOLD FORTRESS stated otherwise),

(a) copy, reproduce, or duplicate the platform or any content or data displayed on the website;

(b) permit other individuals to use the platform;

(c) link to the platform;

(d) modify, translate, reverse engineer, decompile, disassemble (except and solely to the extent applicable law expressly and specifically prohibits such restrictions), or create derivative works based on the platform or any of its contents or any content or data displayed on the website;

(e) modify the operation of the platform;

(f) re-distribute, re-sell, re-transmit, publish, sub-license, disclose, display or make commercial use of the Platform or any content or data provided within the platform or website;

(g) download or copy account information other than if required to do so by an official body or for personal use;

(h) use data mining, robots or similar data gathering and extraction tools on the platform;
